## 24/88. VILLAGE HALL FUTURE PROOFING.

The Parish Council has been awarded £15,000 from Colchester City Councils (Rural England Prosperity Fund) for the Village Hall project. They have also agreed to fund 80% of the cost of an LED Display Unit (total cost £1,551.25) bringing the total grant up to £16,241. A meeting with contractors to be held on 19 July and work could start in August. It is hoped the LED lighting could be done at over a weekend to avoid disruption to hall users.
