Minutes of a meeting of Birch Parish Council, held on Tuesday 2 September 2025, 7.30pm at Birch Memorial Hall.

Birch Pit, Maldon Road – Ben Ayres (Land & Minerals Resources Manager) and Alex Hemming (Landscape Manager) from Heidelberg Materials UK gave a report on plans for Birch Quarry and the proposals for the area allocated for mineral extraction in the current Minerals Local Plan.

Cllr Bentley updated the Council on Local Government Reform (LGR), a decision on the number of unitary authorities should be available in March 2026, a Mayor will be elected in May 2026.

Cllr Bentley would like to organise a meeting to present the LGR proposals to the Colchester parish councils. Neighbourhood Delivery Committees with a budget and powers to be set up for local decision making. Each parish council will have a place on the Committee with voting rights.

The Government are no longer going ahead with the widening of the A12, which could affect housing proposals in the Local Plan.

Details of the cost for the repair of the Memorial Cross to be sent to Cllr Bentley to apply for funding from the City/County Locality Budgets. Funding for the decoration of the Village Hall to be applied for.

Cllr Bentley was asked about the application for the white village gateways, which is in the system, but he will check progress.
