Minutes of a meeting of Birch Parish Council, held on Tuesday 3 June 2025, 7.30pm at Birch Memorial Hall.

25/23. CHAIRMAN'S WELCOME.

The Chairman welcomed those present to the meeting.

25/24. APOLOGIES FOR ABSENCE.

Apologies were received from Cllrs Boyce and Cottrell.

25/25. MINUTES OF THE LAST MEETING.

The minutes of 6 May 2025 were approved as a correct record of events. **Proposed: Clir Ninnim. Seconded: Clir Harris. All agreed.**

25/26. DECLARATION OF INTERESTS.

Mike Watkins, the new Neighbourhood Warden was welcomed to the meeting, he said Birch was the first parish council to invite him to a meeting. Mike explained how the Neighbourhood Warden scheme now works; all issues are logged (Task Smart), he would prefer contact by email: michael.watkins@colchester.gov.uk as this makes it easier to log the details. Mike works four days a week, another colleague covers Mondays. They are trying to gather evidence of fly-tipping and have had some success with prosecutions, they issue fixed penalty notices for smaller issues. Any dumped asbestos is contracted out to specialists for clearing. Fly-tips are taped off to make the area appear like a crime scene to draw attention to the crime.

Cllr Harris suggested that the Council would be willing to put their mobile camera in any hot spots and Mike agreed to look into this.

25/27. REPORTS.

Essex County Council (ECC).

Colchester City Council (CCC). Apologies were received from Cllr Ellis. Cllr Bentley gave an update on the Local Plan and advised the Council to get a wish list in to the City Council for any s.106 money. Cllr Ellis is now the Deputy Mayor at CCC. Councillors Locality Budgets are now open for application with £2,000 and £5,000 available from the City Council and ECC. Cllr Bentley confirmed that the Local Highways Panel (LHP) has not been suspended due to Local Government Reform and existing approved schemes will remain in the LHP.

Cllr Bentley was updated on Birch Church and the email sent to the Bishop of Barking and her reply. There is a Diocese Trustees meeting on 17 July, it was agreed to invite the Bishop to the next Parish Council meeting and to also ask again for a copy of the most recent structural survey report of the Church.
