- 21 bags of rubbish were collected during April, this might slow down for a while due to the verges growing. Dumped asbestos has been marked, some has been collected.

- Large lorries are still using Pudding Lane, although there was no weight restriction, the lane did have a sign saying unsuitable for large vehicles.
- Mill Lane a 'No Through Lane' sign was suggested.
- The Memorial Cross needs some repair work doing Cllr Ninnim will look into finding a specialist to do the work.
- Hare & Hounds a complaint was received regarding extra loud noise from a live band and a large marquee erected up against a neighbour's garden fence with no notice given. The resident concerned has submitted a complaint to the City Council. Cllr Ninnim will speak to the landlord.
- Cllr Boyce gave her apologies for the next meeting.
